**UNANIMOUS CONSENT AGREEMENT**  
**Adalberto Jose Jordan (Cal. No. 437)**

*Ordered*, That at 4:30 pm on Monday, January 23, 2012, the Senate proceed to executive session to consider the nomination of Adalberto Jose Jordan, of Florida, to be United States Circuit Judge for the Eleventh Circuit, that there be one hour for debate equally divided in the usual form; that upon the use or yielding back of time the Senate proceed to vote without intervening action or debate on the nomination; *provided further*, that the motion to reconsider be considered made and laid upon the table with no intervening action or debate; that no further motions be in order; that the President be immediately notified of the Senate's action and the Senate then resume legislative session.
