## UNANIMOUS CONSENT AGREEMENT

Jane Kelly (Cal. No. 60)

*Ordered*, That at a time to be determined by the Majority Leader, in consultation with the Republican Leader, the Senate proceed to executive session to consider the nomination of Jane Kelly, of Iowa, to be United States Circuit Judge for the Eighth Circuit.

*Ordered further*, That there be 30 minutes for debate equally divided in the usual form; that upon the use or yielding back of time the Senate proceed to vote without intervening action or debate on the nomination; that the motion to reconsider be considered made and laid upon the table with no intervening action or debate; that no further motions be in order; that the President be immediately notified of the Senate's action and the Senate then resume legislative session.
