UNANIMOUS CONSENT AGREEMENT

Jane Kelly (Cal. No. 60)
Sylvia Mathews Burwell (Cal. 64)

Ordered, That at 10:30 a.m. on Wednesday, April 24, 2013, the Senate proceed to executive session to consider the nominations of: Jane Kelly, of Iowa, to be United States Circuit Judge for the Eighth Circuit and Sylvia Mathews Burwell, of West Virginia, to be Director of the Office of Management and Budget.

Ordered further, That there be 90 minutes for debate equally divided in the usual form, with the time from 10:30 to 11 a.m., on the Kelly nomination, and the time from 11 a.m. to 12 noon on the Burwell nomination; that upon the use or yielding back of time the Senate proceed to vote without intervening action or debate on the nominations in the order listed; with 2 minutes for debate equally divided in the usual form between the votes; that the second vote be 10 minutes in length; the motions to reconsider be considered made and laid upon the table with no intervening action or debate; that no further motions be in order to the nominations; that the President be immediately notified of the Senate's actions and the Senate then resume legislative session.
