#### UNANIMOUS CONSENT AGREEMENTS

#### Terrell McSweeny (Cal. No. 507)

#### Wanda Felton (Cal. No. 649)

Ordered, That this week, at a time to be determined by the Majority Leader, in consultation with the Republican Leader, the Senate proceed to executive session to consider the nomination of Wanda Felton, of New York, to be First Vice President of the Export-Import Bank of the United States for a term expiring January 20, 2017, that there be one hour for debate, with 15 minutes under the control of the Democratic Leader, or his designee, and 45 minutes under the control of the Republican Leader, or his designee; that upon the use or yielding back of time the Senate proceed to vote on the nomination; the motion to reconsider be considered made and laid upon the table with no intervening action or debate; that no further motions be in order; that the President be immediately notified of the Senate's action and the Senate then resume legislative session. #### Michelle T. Friedland (Cal. No. 574)
