Ordered further, That following the vote on the motion to invoke cloture on the Barron nomination, the Senate proceed to consideration of the nominations of: Elisebeth Collins Cook, of Virginia, to be a Member of the Privacy and Civil Liberties Oversight Board for a term expiring January 29, 2020; James Walter Frazer Green, of Louisiana, to be United States Attorney for the Middle District of Louisiana for the term of four years; Deirdre M. Daly, of Connecticut, to be United States Attorney for the District of Connecticut for the term of four years; and Damon Paul Martinez, of New Mexico, to be United States Attorney for the District of New Mexico for the term of four years and proceed to vote on confirmation of the nominations in the order listed; further, that there be 2 minutes for debated prior to each vote, equally divided in the usual form, that any roll call votes, following the first in each series, be 10 minutes in length; that the motions to reconsider be considered made and laid upon the table with no intervening action or debate; that no further motions be in order to the nominations; and that the President be immediately notified of the Senate's actions.
