## UNANIMOUS CONSENT AGREEMENT

### Alfred H. Bennett (Cal. No. 23)

*Ordered,* That at 5 p.m. on Monday, April 13, 2015, the Senate proceed to executive session to consider the nomination of Alfred H. Bennett, of Texas, to be United States District Judge for the Southern District of Texas.

*Ordered further,* That there be 30 minutes for debate equally divided in the usual form; that upon the use or yielding back of time the Senate proceed to vote without intervening action or debate on the nomination, that following disposition of the nomination the motion to reconsider be considered made and laid upon the table with no intervening action or debate; that no further motions be in order; that the President be immediately notified of the Senate's actions and the Senate then resume legislative session.
