Ordered, That following Leader remarks on Tuesday, October 17, 2017, the Senate proceed to executive session and resume consideration of the nomination of David Joel Trachtenberg, of Virginia, to be a Principal Deputy Under Secretary of Defense.

Ordered further, That there be 10 minutes of debate on the nomination equally divided in the usual form, and that following the use or yielding back of time, the Senate vote on confirmation of the nomination with no intervening action or debate, and that if confirmed, the motion to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate's actions. *(Oct. 5, 16, 2017)*
