Ordered, That following Leader remarks on Thursday, October 26, 2017, the Senate proceed to executive session and resume consideration of the nomination of Scott L. Palk, of Oklahoma, to be United States District Judge for the Western District of Oklahoma.

Ordered further, That at 12 noon, notwithstanding the provisions of Rule XXII, all post-cloture time be considered expired on the Palk nomination, and that following disposition of the Palk nomination, the motion to reconsider be considered made and laid upon the table, the President be immediately notified of the Senate's actions, and the Senate vote on the motion to invoke cloture on the nomination of Trevor N. McFadden, of Virginia, to be United States District Judge for the District of Columbia.

Ordered further, That with respect to the vote on the motion to invoke cloture on the McFadden nomination, the mandatory quorum required under Rule XXII be waived. (*Oct. 23, 25, 2017.*)
