UNANIMOUS CONSENT AGREEMENT

Andrei Iancu (Cal. No. 570)

Ordered, That at 5 p.m., on Monday, February 5, 2018, the Senate proceed to executive session for the consideration of the nomination of Andrei Iancu, of California, to be Under Secretary of Commerce for Intellectual Property and Director of the United States Patent and Trademark Office.

Ordered further, That there then be 30 minutes of debate equally divided in the usual form and that following the use or yielding back of time the Senate vote on the nomination with no intervening action or debate; that if confirmed, the motion to reconsider be considered made and laid upon the table; the President be immediately notified of the Senate's actions, and that no further motions be in order.
