#### UNANIMOUS CONSENT AGREEMENTS

Ney, Jr., of Tennessee, to be General Counsel of the Department of Defense.

Ordered further, That with respect to the motion to invoke cloture on the Ney nomination, the mandatory quorum required under Rule XXII be waived. (Jun. 28, Jul. 10, 2018.)

#### James Blew (Cal. No. 601)

*Ordered*, That at a time to be determined by the Majority Leader in consultation with the Democratic Leader, the Senate proceed to executive session for the consideration of the nomination of James Blew, of California, to be Assistant Secretary for Planning, Evaluation, and Policy Development, Department of Education.

Ordered further, That there be 5 hours of debate, equally divided, and that following the use or yielding back of time the Senate vote on the nomination with no intervening action or debate; that if confirmed, the motion to reconsider be considered made and laid upon the table; the President be immediately notified of the Senate's actions, and that no further motions be in order.
