Ordered, That following Leader remarks on Wednesday, July 17, 2019, the Senate proceed to executive session and resume consideration of the Protocol Amending Tax Convention with Swiss Confederation.

Ordered further, That at 2 p.m., notwithstanding the provisions of Rule XXII, the Senate vote on the cloture motions on the following nominations:

Clifton L. Corker, of Tennessee, to be United States District Judge for the Eastern District of Tennessee;

Lynda Blanchard, of Alabama, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to the Republic of Slovenia; and

Donald R. Tapia, of Arizona, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to Jamaica.

Ordered further, That with respect to the motions to invoke cloture on the above nominations, the mandatory quorum calls required under Rule XXII be waived.

Ordered further, That if cloture is invoked, the confirmation votes occur at a time to be determined by the Majority Leader in consultation with the Democratic Leader on Thursday, July 18, 2019. (Jul. 11, 16, 2019.)
