Ordered, That following Leader remarks on Wednesday, November 6, 2019, the Senate proceed to executive session and resume consideration of the nomination of Lee Philip Rudofsky, of Arkansas, to be United States District Judge for the Eastern District of Arkansas.

Ordered further, That at 12 noon, notwithstanding the provisions of Rule XXII, the cloture votes on the Rudofsky nomination and the nomination of Jennifer Philpott Wilson, of Pennsylvania, to be United States District Judge for the Middle District of Pennsylvania occur.

Ordered further, That at 4 p.m., the confirmation vote on the nomination of Danielle J. Hunsaker, of Oregon, to be United States Circuit Judge for the Ninth Circuit occur.

Ordered further, That following disposition of the Hunsaker nomination, the Senate vote on the motion to invoke cloture on the nomination of William Joseph Nardini, of Connecticut, to be United States Circuit Judge for the Second Circuit.

Ordered further, That if cloture is invoked on the Rudofsky, Wilson, and Nardini nominations, the confirmation votes occur at a time to be determined by the Majority Leader in consultation with the Democratic Leader on Thursday, November 7, 2019.

Ordered further, That with respect to the motions to invoke cloture on the Rudofsky, Wilson, and Nardini nominations, the mandatory quorum calls required under Rule XXII be waived. (*Oct. 31, Nov. 5, 2019.*)
