## UNANIMOUS CONSENT AGREEMENT

*Ordered*, That following Leader remarks on Wednesday, December 4, 2019, the Senate proceed to executive session and resume consideration of the nomination of Richard Ernest Myers II, of North Carolina, to be United States District Judge for the Eastern District of North Carolina.

John L. Sinatra, Jr., of New York, to be United States District Judge for the Western District of New York;

Douglas Russell Cole, of Ohio, to be United States District Judge for the Southern District of Ohio;

R. Austin Huffaker, Jr., of Alabama, to be United States District Judge for the Middle District of Alabama; and

David B. Barlow, of Utah, to be United States District Judge for the District of Utah.
