UNANIMOUS CONSENT AGREEMENT

Christopher Waller (Cal. No. 761) Liam P. Hardy (Cal. No. 842)

Ordered, That following Leader remarks on Thursday, December 3, 2020, the Senate proceed to executive session to resume consideration of the nomination of Christopher Waller, of Minnesota, to be a Member of the Board of Governors of the Federal Reserve System for a term of fourteen years from February 1, 2016.

Ordered further, That at 11:30 a.m., notwithstanding the provisions of Rule XXII, the post-cloture time on the Waller nomination expire and the Senate vote on confirmation of the nomination.

Ordered further, That if cloture is invoked on the nomination of Liam P. Hardy, of Virginia, to be a Judge of the United States Court of Appeals for the Armed Forces for the term of fifteen years to expire on the date prescribed by law, the post-cloture time expire at 1:45 p.m., and the Senate vote on confirmation of the nomination.

Ordered further, That if any of the nominations are confirmed, the motions to reconsider be considered made and laid upon the table and the President be immediately notified of the Senate's actions. (Dec. 2, 2020.)
