## UNANIMOUS CONSENT AGREEMENT

**Marcia Louise Fudge (Cal. No. 12)**  
**Merrick Brian Garland (Cal. No. 27)**  
**Michael Stanley Regan (Cal. No. 15)**

*Ordered,* That upon the closure of morning business on Tuesday, March 9, 2021, the Senate proceed to executive session to resume consideration of the nomination of Marcia Louise Fudge, of Ohio, to be Secretary of Housing and Urban Development.

*Ordered further,* That at 5:30 p.m., the cloture motions ripen on the Fudge nomination and the nomination of Merrick Brian Garland, of Maryland, to be Attorney General.

*Ordered further,* That the Senate proceed to vote on cloture of the Fudge nomination, that if cloture is invoked, post-cloture time expire on Wednesday, March 10, 2021, at 12:00 noon.

*Ordered further,* That notwithstanding the provisions of Rule XXII, following the cloture vote on the Fudge nomination, the Senate vote on cloture on the Garland nomination; that if cloture is invoked on the Garland nomination, post-cloture time expire on Wednesday, March 10, 2021 at 2:15 p.m.

*Ordered further,* That cloture on the nomination of Michael Stanley Regan, of North Carolina, to be Administrator of the Environmental Protection Agency ripen following disposition of the Garland nomination.

*Ordered further,* That with respect to the motions to invoke cloture on the Fudge, Garland, and Regan nominations, the mandatory quorum calls required under Rule XXII be waived. (*Mar. 6, 2021.*)
