Ordered, That at 12 noon on Tuesday, April 20, 2021, the Senate proceed to executive session to resume consideration of the nomination of Gary Gensler, of Maryland, to be a Member of the Securities and Exchange Commission for a term expiring June 5, 2026, and the Senate vote on the motion to invoke cloture on the nomination.

Ordered further, That with respect to the motion to invoke cloture on the Gensler nomination, the mandatory quorum call required under Rule XXII be waived.

Ordered further, That the Senate recess following the cloture vote on the Gensler nomination until 2:15 p.m. to allow for the weekly caucus meetings.

 $Ordered\ further,$ That if cloture is invoked on the Gensler nomination, all post-cloture time be considered expired at 2:15 p.m.

Ordered further, That if confirmed, the motion to reconsider be considered made and laid upon the table and the President be immediately notified of the Senate's actions.

 $Ordered\ further,$ That following the confirmation vote on the Gensler nomination, the Senate resume legislative session.

Ordered further, That the vote on confirmation of the nomination of Lisa O. Monaco, of the District of Columbia, to be Deputy Attorney General occur at a time to be determined by the Majority Leader in consultation with the Republican Leader on Tuesday, April 20, 2021. (Apr. 15, 19, 2021.)


