## UNANIMOUS CONSENT AGREEMENT

### **Chiquita Brooks-LaSure (Cal. No. 117)** **Kristen M. Clarke (Cal. No. 124)**

*Ordered,* That upon the conclusion of morning business on Tuesday, May 25, 2021, the Senate proceed to executive session to resume consideration of the nomination of Chiquita Brooks-LaSure, of Virginia, to be Administrator of the Centers for Medicare and Medicaid Services, post-cloture.

*Ordered further,* That the Senate recess following the cloture vote on the nomination of Kristen M. Clarke, of the District of Columbia, to be an Assistant Attorney General until 2:15 p.m. to allow for the weekly caucus meetings.

*Ordered further,* That with respect to the motion to invoke cloture on the Clarke nomination, the mandatory quorum call required under Rule XXII be waived.

*Ordered further,* That if cloture is invoked on the Clarke nomination, all post-cloture debate time be considered expired at 2:30 p.m.

*Ordered further,* That if any of the nominations are confirmed, the motions to reconsider be considered made and laid upon the table and the President be immediately notified of the Senate's actions. (*May 20, 24, 2021.*)
