*Ordered*, That upon the conclusion of morning business on Thursday, October 28, 2021, the Senate proceed to executive session to resume consideration of the nomination of Omar Antonio Williams, of Connecticut, to be United States District Judge for the District of Connecticut.

*Ordered further*, That at 11 a.m., the Senate vote on confirmation of the Williams nomination and the nominations of Matthew G. Olsen, of Maryland, to be an Assistant Attorney General and Christopher H. Schroeder, of North Carolina, to be an Assistant Attorney General, in the order listed.

*Ordered further*, That upon disposition of the Schroeder nomination, the Senate resume consideration of the nomination of Hampton Y. Dellinger, of North Carolina, to be an Assistant Attorney General, post-cloture.

Ordered further, That at 2:30 p.m., the Senate vote on confirmation of the Dellinger nomination and the nomination of Elizabeth Prelogar, of Idaho, to be Solicitor General of the United States prior to votes on the motions to invoke cloture on the nominations of Beth Robinson, of Vermont, to be United States Circuit Judge for the Second Circuit and Toby J. Heytens, of Virginia, to be United States Circuit Judge for the Fourth Circuit, all in the order listed.

*Ordered further*, That with respect to the motions to invoke cloture on the Robinson and Heytens nominations, the mandatory quorum calls required under Rule XXII be waived.

*Ordered further*, That if cloture is invoked on any of the nominations during Thursday's session, all post-cloture time expire immediately and the Senate vote on confirmation of the nominations at a time to be determined by the Majority Leader in consultation with the Republican Leader.

Ordered further, That if any nominations are confirmed during Thursday's session, the motions to reconsider be considered made and laid upon the table and the President be immediately notified of the Senate's actions. (Oct. 25, 27, 2021.)
