UNANIMOUS CONSENT AGREEMENT

Brian Eddie Nelson (Cal. No. 463)

Ordered, That upon the conclusion of morning business on Wednesday, November 17, 2021, the Senate proceed to executive session to resume consideration of the nomination of Brian Eddie Nelson, of California, to be Under Secretary for Terrorism and Financial Crimes.

Ordered further, That with respect to the motion to invoke cloture on the Nelson nomination, the mandatory quorum call required under Rule XXII be waived.

Ordered further, That at 10 a.m., notwithstanding the provisions of Rule XXII, the cloture votes on the Nelson nomination and the motion to proceed to H.R. 4350 occur.

Ordered further, That if cloture is invoked on the Nelson nomination, all post-cloture time be considered expired, and the Senate vote on confirmation of the nomination at a time to be determined by the Majority Leader following consultation with the Republican Leader. *(Nov. 4, 16, 2021.)*
