UNANIMOUS CONSENT AGREEMENTS

Ordered, That upon the conclusion of morning business on Wednesday, May 11, 2022, the Senate proceed to executive session to resume consideration of the motion to discharge the Committee on the Judiciary from further consideration of the nomination of Charlotte N. Sweeney, of Colorado, to be United States District Judge for the District of Colorado.

Ordered further, That at 11 a.m., the vote on the motion to discharge the Sweeney nomination occur.

Ordered further, That following the disposition of the motion to discharge the Sweeney nomination, the

cloture motions on the nominations of Alvaro M. Bedoya, of Maryland, to be a Federal Trade Commissioner for the term of seven years from September 26, 2019 and Julia Ruth Gordon, of Maryland, to be an Assistant Secretary of Housing and Urban Development, ripen.

Ordered further, That with respect to the motions to invoke cloture on the Bedoya and Gordon nominations, the mandatory quorum calls required under Rule XXII be waived.

Ordered further, That if cloture is invoked on the Bedoya nomination, all post-cloture time be considered expired at 2:30 p.m.

Ordered further, That if any nominations are confirmed during Wednesday's session, the motions to reconsider be considered made and laid upon the table and the President be immediately notified of the Senate's actions. (May 9, 10, 2022.)

Ordered, That at a time to be determined by the Majority Leader in consultation with the Republican Leader, notwithstanding Rule XXII, the Senate proceed to executive session to consider the nominations of Jerome H.
