#### UNANIMOUS CONSENT AGREEMENT

#### Joseph Lee Falk (PN61) Roger Israel Zakheim (PN62)

*Ordered*, That at a time to be determined by the Majority Leader, in consultation with the Republican Leader, the Senate proceed to executive session to consider the nomination of Joseph Lee Falk, of Florida, to be a Member of the Board of Directors of the United States Institute of Peace for a term of four years.

*Ordered further*, That there be 10 minutes for debate equally divided in the usual form on the nomination; that upon the use or yielding back of time the Senate vote on the nomination, without intervening action or debate.

*Ordered further*, That if the Falk nomination is not confirmed, all action with respect to the Falk nomination and the nomination of Roger Israel Zakheim, of Maryland, to be a Member of the Board of Directors of the United States Institute of Peace for a term of four years be vitiated. *(Jan. 30, 2023.)*
