Ordered, That upon the conclusion of morning business on Wednesday, May 15, 2024, the Senate proceed to executive session to resume consideration of the nomination of Courtney Diesel O'Donnell, of California, to be United States Permanent Representative to the United Nations Educational, Scientific, and Cultural Organization, with the rank of Ambassador, post-cloture.

Ordered further, That at 11:30 a.m., all time on the O'Donnell nomination be considered expired.

Ordered further, That with respect to the motions to invoke cloture on the nominations of Sanket Jayshukh Bulsara, of New York, to be United States District Judge for the Eastern District of New York and Seth Robert Aframe, of New Hampshire, to be United States Circuit Judge for the First Circuit, the mandatory quorum calls required under Rule XXII be waived.

Ordered further, That following the cloture vote on the Bulsara nomination, the Senate recess until 2:15 p.m. to allow for the weekly caucus meetings.

Ordered further, That if cloture has been invoked on the Bulsara nomination, at 2:15 p.m. the Senate vote on confirmation of the nomination.

Ordered further, That at 1:45 p.m. on Thursday, May 16, 2024, the cloture motion with respect to the Aframe nomination ripen.

Ordered further, That upon disposition of the Bulsara nomination, the Senate execute the order of May 7, 2024, with respect to the nomination of Eric C. Schulte, of South Dakota, to be United States District Judge for the District of South Dakota.

Ordered further, That upon disposition of the Schulte nomination, the Senate resume legislative session.

Ordered further, That if any nominations are confirmed during Wednesday's session, the motions to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate's actions. (May 9, 14, 2024.)
