*Ordered*, That following the conclusion of morning business on Thursday, November 14, 2024, the Senate proceed to executive session to resume consideration of the nomination of Cathy Fung, of California, to be a Judge of the United States Tax Court for a term of fifteen years.

*Ordered further*, That at 11:30 a.m., all post-cloture time on the Fung nomination be considered expired.

*Ordered further*, That following disposition of the Fung nomination, the Senate immediately vote on confirmation of the nomination of David Huitema, of Maryland, to be Director of the Office of Government Ethics for a term of five years.

*Ordered further*, That immediately following the confirmation vote on the Huitema nomination, the Senate resume consideration of the nomination of Embry J. Kidd, of Florida, to be United States Circuit Judge for the Eleventh Circuit.
