Sean Duffy (Cal. No. 6) (PN11-6)

Ordered, That following the conclusion of morning business on Monday, January 27, 2025, the Senate proceed to executive session and resume consideration of the nomination of Scott Bessent, of South Carolina, to be Secretary of the Treasury, post-cloture.

Ordered further, That cloture having been invoked on the Bessent nomination, all post-cloture time be considered expired and the Senate vote on confirmation of the nomination at 5:30 p.m.

Ordered further, That if cloture is invoked on the nomination of Sean Duffy, of Wisconsin, to be Secretary of Transportation, all post-cloture time be considered expired and the Senate vote on confirmation of the nomination at 12 noon on Tuesday, January 28, 2025.

Ordered further, That if any nominations are confirmed during Monday's session, the motions to reconsider be considered made and laid upon the table and the President be immediately notified of the Senate's actions. *(Jan. 24, 25, 2025.)*
