Ordered, That at 11:30 a.m. on Tuesday, April 8, 2025, notwithstanding Rule XXII, all post-cloture time with respect to the nomination of Elbridge Colby, of the District of Columbia, to be Under Secretary of Defense for Policy be deemed expired, and the Senate proceed to executive session and resume consideration of the Colby nomination and the Senate vote on confirmation of the nomination.

Ordered further, That following confirmation of the Colby nomination, the cloture motions with respect to the following nominations ripen:

George Glass, of Oregon, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to Japan;

Mike Huckabee, of Arkansas, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to the State of Israel;

Peter Hoekstra, of Michigan, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to Canada;

Ronald Johnson, of Florida, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to the United Mexican States;

Kevin Cabrera, of Florida, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to the Republic of Panama; and

Paul Atkins, of Virginia, to be a Member of the Securities and Exchange Commission for the remainder of the term expiring June 5, 2026.

Ordered further, That following the confirmation vote on the Colby nomination, the Senate vote on the motion to invoke cloture on the Glass nomination.

Ordered further, That if cloture is invoked on the Glass nomination, the Senate recess until 2:15 p.m. to allow for the weekly conference meetings.

Ordered further, That at 2:15 p.m., the Senate vote on confirmation of the Glass nomination.

Ordered further, That following disposition of the Glass nomination, the Senate vote on the motion to invoke cloture on the Huckabee nomination.

Ordered further, That if any nominations are confirmed during Tuesday's session, the motions to reconsider be considered made and laid upon the table and the President be immediately notified of the Senate's actions. (Apr. 7, 2025.)
