*Ordered*, That at 11:30 a.m. on Tuesday, April 8, 2025, notwithstanding Rule XXII, all post-cloture time with respect to the nomination of Elbridge Colby, of the District of Columbia, to be Under Secretary of Defense for Policy be deemed expired, and the Senate proceed to executive session and resume consideration of the Colby nomination and the Senate vote on confirmation of the nomination.
