Ordered further, That if cloture is invoked, the Senate vote on confirmation of the nomination of Mike Huckabee, of Arkansas, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to the State of Israel.

Ordered further, That at 2 p.m., the Senate vote on confirmation of the following nominations in the order listed:

Peter Hoekstra, of Michigan, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to Canada;

Ronald Johnson, of Florida, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to the United Mexican States; and

Kevin Cabrera, of Florida, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to the Republic of Panama.
