Ordered further, That if cloture is invoked, the Senate vote on confirmation of the nomination of Mike Huckabee, of Arkansas, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to the State of Israel.

Peter Hoekstra, of Michigan, to be Ambassador Extraordinary and Plenipotentiary of the United States of America to Canada;
