*Ordered further*, That if cloture is invoked on the Hermandorfer nomination, all post-cloture time be considered expired and the Senate vote on confirmation of the nomination at a time to be determined by the Majority Leader in consultation with the Democratic Leader on Monday, July 14, 2025.
