Ordered further, That if cloture is invoked on the Hermandorfer nomination, all post-cloture time be considered expired and the Senate vote on confirmation of the nomination at a time to be determined by the Majority Leader in consultation with the Democratic Leader on Monday, July 14, 2025.

Ordered further, That if any nominations are confirmed during Thursday or Monday's sessions of the Senate, the motions to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate's actions. *(July 9, 2025.)*
