Ordered, That upon the conclusion of morning business on Tuesday, July 15, 2025, the Senate proceed to executive session and resume consideration of the nomination of Luke Pettit, of the District of Columbia, to be an Assistant Secretary of the Treasury, post-cloture.

Ordered further, That at 11:30 a.m., notwithstanding Rule XXII, the Senate vote on confirmation of the Pettit nomination.

Ordered further, That if cloture is invoked on the nomination of Anthony Tata, of Florida, to be Under Secretary of Defense for Personnel and Readiness, the Senate recess subject to the call of the Chair following the cloture vote to allow for the weekly conference meetings.

Ordered further, That when the Senate reconvenes, all post-cloture time be expired and the Senate vote on confirmation of the Tata nomination, and if confirmed, the Senate then vote on the motion to invoke cloture on the nomination of Joseph Edlow, of Maryland, to be Director of United States Citizenship and Immigration Services, Department of Homeland Security.

Ordered further, That if any nominations are confirmed during Tuesday's session of the Senate, the motions to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate's actions. *(July 14, 2025.)*
