Ordered, That at 12:15 p.m. on Wednesday, May 21, 2014, the Senate proceed to executive session and all post-cloture time be expired and the Senate proceed to vote on the confirmation of the nomination of Stanley Fischer, of New York, to be a Member of the Board of Governors of the Federal Reserve System for the unexpired term of fourteen years from February 1, 2006; further, that following disposition of the Fischer nomination the Senate stands in recess until 2 p.m.; that at 2 p.m., there be 10 minutes for debate, equally divided between the two Leaders, or their designees, prior to a vote on the motion to invoke cloture on the nomination of David Jeremiah Barron, of Massachusetts, to be United States Circuit Judge for the First Circuit.

Ordered further, That if cloture is invoked on the Barron nomination, at 2 p.m. on Thursday, May 22, 2014, all post-cloture time be expired and the Senate proceed to vote on confirmation of the Barron nomination.

Ordered further, That following the vote on the motion to invoke cloture on the Barron nomination, the Senate proceed to consideration of the nominations of: Elisebeth Collins Cook, of Virginia, to be a Member of the Privacy and Civil Liberties Oversight Board for a term expiring January 29, 2020; James Walter Frazer Green, of Louisiana, to be United States Attorney for the Middle District of Louisiana for the term of four years; Deirdre M. Daly, of Connecticut, to be United States Attorney for the District of Connecticut for the term of four years; and Damon Paul Martinez, of New Mexico, to be United States Attorney for the District of New Mexico for the term of four years and proceed to vote on confirmation of the nominations in the order listed; further, that there be 2 minutes for debated prior to each vote, equally divided in the usual form, that any roll call votes, following the first in each series, be 10 minutes in length; that the motions to reconsider be considered made and laid upon the table with no intervening action or debate; that no further motions be in order to the nominations; and that the President be immediately notified of the Senate's actions.
