*Ordered*, That following any leader remarks, on Monday, July 28, 2014, the Senate proceed to executive session and resume consideration of the nomination of Pamela Harris, of Maryland, to be United States Circuit Judge for the Fourth Circuit.

*Ordered further*, That the time until 5:30 p.m. be equally divided between the two Leaders or their designees, and that at 5:30 p.m. all post-cloture time be deemed expired and the Senate proceed to vote on confirmation of the nomination.

*Ordered further*, That upon disposition of the Harris nomination, the Senate proceed to the consideration of the following nominations:

Elliot F. Kaye, of New York, to be a Commissioner of the Consumer Product Safety Commission for a term of seven years from October 27, 2013;
