Jeffery Martin Baran, of Virginia, to be a Member of the Nuclear Regulatory Commission for the remainder of the term expiring June 30, 2015; and

Stephen G. Burns, of Maryland, to be a Member of the Nuclear Regulatory Commission for the term of five years expiring June 30, 2019.

*Ordered further*, That with respect to the votes on the motions to invoke cloture on the nominations, the mandatory quorum required under Rule XXII be waived.

*Ordered further*, That if cloture is invoked on either of these nominations, that at 2:15 p.m. on Tuesday, September 16, 2014, all post-cloture time be expired, and the Senate proceed to vote on confirmation of the nominations in the order upon which cloture was invoked.

*Ordered further*, That there be two minutes for debate prior to each vote; that all roll call votes, following the first in the sequence, be 10 minutes in length; that with respect to the nominations in this agreement, that if any nomination is confirmed, the motion to reconsider be considered made and laid upon the table; and that the President be immediately notified of the Senate's actions.
