UNANIMOUS CONSENT AGREEMENT

Kevin Allen Hassett (Cal. No. 110)

Ordered, That at 2:15 p.m., on Tuesday, September 12, 2017, notwithstanding the provisions of Rule XXII, the Senate proceed to executive session for consideration of the nomination of Kevin Allen Hassett, of Massachusetts, to be Chairman of the Council of Economic Advisers.

Ordered further, That there be 20 minutes of debate on the nomination equally divided in the usual form, and that following the use or yielding back of time, the Senate vote on confirmation with no intervening action or debate, and that if confirmed, the motion to reconsider be considered made and laid upon the table and the President be immediately notified of the Senate's actions, and the Senate resume legislative session.
