UNANIMOUS CONSENT AGREEMENT

Ordered, That at 11 a.m. on Tuesday, November 7, 2017, the Senate proceed to the consideration of the nomination of John H. Gibson II, of Texas, to be Deputy Chief Management Officer of the Department of Defense.

Ordered further, That there be 60 minutes of debate on the nomination equally divided in the usual form, and that following the use or yielding back of time, the Senate vote on confirmation with no intervening action or debate, and that if confirmed, the motion to reconsider be considered made and laid upon the table, and the President be immediately notified of the Senate's actions.

Ordered further, That following disposition of the Gibson nomination, notwithstanding the provisions of Rule XXII, the pending cloture motions ripen on the following nominations:

Steven Andrew Engel, of the District of Columbia, to be an Assistant Attorney General;

Peter B. Robb, of Vermont, to be General Counsel of the National Labor Relations Board for a term of four years;

William L. Wehrum, of Delaware, to be an Assistant Administrator of the Environmental Protection Agency; and

Derek Kan, of California, to be Under Secretary of Transportation for Policy.

Ordered further, That with respect to the motions to invoke cloture on the nominations listed above, the mandatory quorums required under Rule XXII be waived.

Ordered further, That if cloture is invoked on the Engel nomination, the time post-cloture be counted as if invoked at 5:30 p.m., on Monday, November 6, 2017. (*Oct. 26, Nov. 2, 6, 2017.*)
