Ordered further, That following the cloture vote on the Abruzzo nomination, the Senate recess until 2:15 p.m. to allow for the weekly caucus meetings.

Ordered further, That if cloture is invoked on the Polite nomination, all post-cloture time expire at 2:30 p.m.

Ordered further, That if the nomination is confirmed, the motion to reconsider be considered made and laid upon the table and the President be immediately notified of the Senate's actions.

Ordered further, That if cloture is invoked on the Abruzzo nomination, all post-cloture time be immediately expired, and the Senate vote on the confirmation of the nomination at a time to be determined by the Majority Leader in consultation with the Republican Leader on Wednesday, July 21, 2021.
