## UNANIMOUS CONSENT AGREEMENTS

### **Ketanji Brown Jackson (Cal. No. 860)**

*Ordered*, That upon the conclusion of morning business on Thursday, April 7, 2022, the Senate proceed to executive session to resume consideration of the nomination of Ketanji Brown Jackson, of the District of Columbia, to be an Associate Justice of the Supreme Court of the United States.

*Ordered further*, That at 10 a.m., notwithstanding the provisions of Rule XXII, the Senate resume legislative session.

*Ordered further*, That upon disposition of H.R. 6968, the Senate resume executive session and vote on the motion to invoke cloture on the Jackson nomination.

*Ordered further*, That with respect to the motion to invoke cloture on the Jackson nomination, the mandatory quorum call required under Rule XXII be waived.

*Ordered further*, That if any nominations are confirmed during Thursday's session of the Senate, the motions to reconsider be considered made and laid upon the table and the President be immediately notified of the Senate's actions. (*Apr. 6, 2022.*)
