## UNANIMOUS CONSENT AGREEMENTS

**Nina Nin-Yuen Wang (Cal. No. 1035) (PN1688)**  
**Nancy L. Maldonado (Cal. No. 988) (PN1968)**

*Ordered*, That upon the conclusion of morning business on Monday, July 18, 2022, the Senate proceed to executive session and resume consideration of the nomination of Nina Nin-Yuen Wang, of Colorado, to be United States District Judge for the District of Colorado.

*Ordered further*, That at 5:30 p.m., the cloture motions on the Wang nomination and the nomination of Nancy L. Maldonado, of Illinois, to be United States District Judge for the Northern District of Illinois ripen.

*Ordered further*, That with respect to the motions to invoke cloture on the nominations, the mandatory quorum calls required under Rule XXII be waived. (*Jul. 14, 2022.*)

**Julianna Michelle Childs (Cal. No. 968) (PN1671)**

*Ordered*, That at a time to be determined by the Majority Leader, or his designee, following consultation with the Republican Leader, the Senate vote on confirmation of the nomination of Julianna Michelle Childs, of South Carolina, to be United States Circuit Judge for the District of Columbia Circuit. (*Jul. 14, 2022.*)

**Bernadette M. Meehan (Cal. No. 920) (PN787)**

*Ordered*, That at a time to be determined by the Majority Leader, in consultation with the Republican Leader, notwithstanding Rule XXII, if applicable, the Senate proceed to executive session to consider the nomination of Bernadette M. Meehan, to be Ambassador to the Republic of Chile.

*Ordered further*, That there be 10 minutes for debate equally divided in the usual form on the nomination; that upon the use or yielding back of time the Senate proceed to vote without intervening action or debate on the nomination.

*Ordered further*, That if the nomination is confirmed, the motion to reconsider be considered made and laid upon the table with no intervening action or debate; that no further motions be in order on the nomination; that the President be immediately notified of the Senate's actions, and the Senate then resume legislative session. (*Jun. 23, 2022.*)

**Cathy Ann Harris (Cal. No. 716) (PN1599)**

*Ordered*, That cloture having been invoked on nomination of Cathy Ann Harris, of Maryland, to be Chairman of the Merit Systems Protection Board, all post-cloture time be considered expired, and the Senate vote on confirmation of the nomination at a time to be determined by the Majority Leader, or his designee, following consultation with the Republican Leader.
